GENERAL PRICE LIST

These prices are effective as of February 1, 2025 but may be subject to change without notice.

In compliance with the Trade Regulations of the Federal Trade Commission (16CFR Part 453), we are required to provide you this General Price List for retention. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

<b>Basic Services of Funeral Director &amp; Staff:</b>	<b>\$1,595.</b>
Our fee for basic services of the funeral director and staff includes, but is not limited to, the following: staff to respond to initial request for service; arrangement conference with the family or responsible party; consultation with family and clergy; arrangement of funeral; preparation and filing of necessary notices; authorizations and consents; coordination with those providing other portions of the funeral. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses.

<b>Standard Embalming</b>	<b>\$995.</b>
Autopsy Embalming	\$1,095.
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Michigan law requires embalming when death was caused by certain infections diseases or, with very limited exceptions, when the body is not taken to its final destination (such as a cemetery or crematory) within 48 hours of the time of death. Most common carriers also require embalming.

**Forwarding of Remains to Another Funeral Home:**

Our charge includes the removal of remains from place of death, basic services of funeral director & staff, embalming, minimum combination container for remains, necessary authorizations and local transportation to nearest airport. The cost of transportation beyond a radius of 30 miles in funeral home vehicle is \$5.00/per mile. It does NOT include the service of staff or the use of facilities for any viewing (visitation, wake, family hour), rites or ceremonies prior to forwarding the remains or common carrier charges.

**Receiving the Body From Another Funeral Home: .....\$2,565.**

Our charge includes limited basic services of funeral director & staff, local transportation to funeral home & hearse (local) to cemetery or crematory. The cost of transportation beyond a radius of 20 miles in funeral home vehicle is \$3.50/per mile. It does NOT include the use of facilities for any viewing (visitation, wake, family hour), rites/ceremonies after receiving the remains, common carrier charges.

**Direct Cremation: .....\$1,495.**

Our charge for a direct cremation without ceremony includes limited basic services of funeral director & staff, local transfer of deceased, Saginaw County Health Department Cremation Permit (if death occurs in a different county, up to \$63 will be applied to cremation permit), crematory fee, \*alternative cremation container (see description below), and a temporary plastic container provided by the crematory. Other charges will apply for the use of the facilities or staff for viewing, visitation, or ceremony, public or private, or any other goods or services except those expressly set out above. The cost of transportation beyond a radius of 30 miles in funeral home vehicle is \$5.00/per mile.

*\*The crematory requires the use of an alternative container for direct cremation. If you want to arrange a direct cremation, you may use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard or composite material.*

**Family ID Viewing with Cremation:.....\$2,295.**

The private family viewing without any rites or ceremonies prior to cremation is limited to 15 people for 1 hour. Our fee includes washing, grooming, other appropriate preparation of the body, transportation of remains, transportation to crematory, Saginaw County Cremation Permit, crematory fees, basic services of the staff, and alternative cremation container. Please note that this service is available at the sole discretion of the funeral director and is not available in all cases (e.g. trauma, autopsy, cases of disease or extended delay in viewing from the time of death). Embalming may be required. Family ID Viewings will be conducted at the funeral home Monday – Friday between 9:00 a.m. and 4:00 p.m.

**Immediate Burial: .....\$3,015.**

Our charge for an immediate burial without any attendant rites or ceremonies includes the local removal of remains from place of death (within 20 mile radius) and shelter of remains, local transportation (within a 20 mile radius) of remains to cemetery, limited basic services of funeral director & staff, and other preparation of the body. Our charges do NOT include embalming, viewing, visitation, or ceremony, public or private. Nor do they include the actual cost of the grave at the cemetery, the cemetery’s charges for the opening and closing of the grave, the preparation of the gravesite, or any other goods or services except those expressly set out above.

**Anatomical Donation: .....\$2,070.**

Our charge for anatomical donation without any attendant rites or ceremonies includes local removal within (30 mile radius), basic services of funeral director & staff. An additional \$5.00 per mile to the medical school will be charged.
